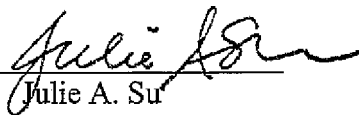
28 A) Bid on or be awarded a contract for a public works project; or

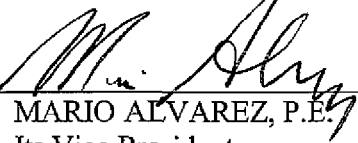
