ORDER OF SUSPENSION

WHEREAS, Labor Code section 139.21(a)(1)(A) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider if the individual has been convicted of any felony or misdemeanor described in Labor Code section 139.21(a)(1)(A); and

WHEREAS, on or about March 10, 2009, Mark Anderson pled guilty to or was found guilty of one or more felonies or misdemeanors described in Labor Code section 139.21(a)(1)(A) in the Superior Court of California, County of Yolo; and

WHEREAS, Labor Code section 139.21(a)(1)(B) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider who has been suspended, due to fraud or abuse, from the federal Medicare or Medicaid programs; and

WHEREAS, Mark Anderson was suspended, due to fraud or abuse, from the federal Medicare or Medicaid programs; and

WHEREAS, Labor Code section 139.21(a)(1)(C) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider whose license, certification or approval to provide health care services has been surrendered or revoked; and

WHEREAS, on or about January 1, 2011, Mark Anderson's license, certification or approval to provide health care services was surrendered or revoked by the Dental Board of California, Department

1 of Consumer Affairs; and

2 WHEREAS, on or about September 22, 2017, the Administrative Director mailed to Mark
3 Anderson a written notice of the right to a hearing regarding the suspension and the procedure to follow
4 to request a hearing, as provided in Labor Code section 139.21(b)(2) and California Code of
5 Regulations, title 8, section 9788.1; and


6 WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of Regulations,
7 title 8, section 9788.1(d), the written notice advised Mark Anderson that the suspension would start
8 thirty (30) calendar days after the date of mailing of written notice, unless Mark Anderson submitted a
9 written request for a hearing within ten (10) calendar days of the date of mailing of the notice; and

10 WHEREAS, Mark Anderson did not submit a written request for hearing within ten (10)
11 calendar days of the date of mailing of the notice; and

12 WHEREAS, the Administrative Director is required to suspend any physician, practitioner, or
13 provider pursuant to Labor Code section 139.21 and Title 8, California Code of Regulations section
14 9788.2, after thirty (30) days from the date the notice was mailed, unless the physician, practitioner, or
15 provider submits a written request for a hearing within ten (10) calendar days of the date of mailing of
16 the notice;

17 **IT IS HEREBY ORDERED** that Mark Anderson is hereby suspended from participating in the
18 workers' compensation system as a physician, practitioner, or provider.
