**ORDER OF SUSPENSION**

WHEREAS, Labor Code section 139.21(a)(1)(A) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider if the individual has been convicted of any felony or misdemeanor described in Labor Code section 139.21(a)(1)(A); and

WHEREAS, on or about April 29, 2022, Respondent Oswaldo Dimas Forero (Oswaldo Forero) pled guilty to or was found guilty of one or more felonies or misdemeanors described in Labor Code section 139.21(a)(1)(A) in the California Superior Court, County of Riverside; and

WHEREAS, on or about May 24, 2023, the Administrative Director mailed to Oswaldo Forero a written notice of the right to a hearing regarding the suspension and the procedure to follow to request a hearing, as provided in Labor Code section 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1; and

WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1(d), the written notice advised Oswaldo Forero that the suspension would start thirty (30) calendar days after the date of mailing of written notice, unless Oswaldo Forero submitted a written request for a hearing within ten (10) calendar days of the date of mailing of the notice; and

WHEREAS, Oswaldo Forero did not submit a written request for hearing within ten (10) calendar days of the date of mailing of the notice; and

1           WHEREAS, the Administrative Director is required to suspend any physician,  
2 practitioner, or provider pursuant to Labor Code section 139.21 and California Code of  
3 Regulations, title 8, section 9788.2, after thirty (30) days from the date the notice was mailed,  
4 unless the physician, practitioner, or provider submits a written request for a hearing within ten  
5 (10) calendar days of the date of mailing of the notice;

6           **IT IS HEREBY ORDERED** that Oswaldo Forero is hereby suspended from participating  
7 in the workers' compensation system as a physician, practitioner, or provider.
