**ORDER OF SUSPENSION**

ROUZBEH JAVAHERIAN,  
Respondent.

10 WHEREAS, Labor Code section 139.21(a)(1)(A) requires the Administrative Director to  
11 suspend any physician, practitioner, or provider from participating in the workers' compensation system  
12 as a physician, practitioner, or provider if the individual has been convicted of any felony or  
13 misdemeanor described in Labor Code section 139.21(a)(1)(A); and

14 WHEREAS, on or about March 16, 2015, Rouzbeh Javaherian pled guilty to or was found guilty  
15 of one or more felonies or misdemeanors described in Labor Code section 139.21(a)(1)(A) in the United  
16 States District Court, Central District of California; and

17 WHEREAS, Labor Code section 139.21(a)(1)(B) requires the Administrative Director to  
18 suspend any physician, practitioner, or provider from participating in the workers' compensation system  
19 as a physician, practitioner, or provider who has been suspended, due to fraud or abuse, from the federal  
20 Medicare or Medicaid programs; and

21 WHEREAS, Rouzbeh Javaherian was suspended, due to fraud or abuse, from the federal  
22 Medicare or Medicaid programs; and

23 WHEREAS, Labor Code section 139.21(a)(1)(C) requires the Administrative Director to  
24 suspend any physician, practitioner, or provider from participating in the workers' compensation system  
25 as a physician, practitioner, or provider whose license, certification or approval to provide health care  
26 services has been surrendered or revoked; and

27 WHEREAS, on or about April 12, 2018, Rouzbeh Javaherian's license, certification or approval  
28 to provide health care services was surrendered or revoked by the California Board of Pharmacy,  
Department of Consumer Affairs; and

1           WHEREAS, on or about July 27, 2018, the Administrative Director mailed to Rouzbeh  
2 Javaherian a written notice of the right to a hearing regarding the suspension and the procedure to follow  
3 to request a hearing, as provided in Labor Code section 139.21(b)(2) and California Code of  
4 Regulations, title 8, section 9788.1; and


5           WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of Regulations,  
6 title 8, section 9788.1(d), the written notice advised Rouzbeh Javaherian that the suspension would start  
7 thirty (30) calendar days after the date of mailing of written notice, unless Rouzbeh Javaherian  
8 submitted a written request for a hearing within ten (10) calendar days of the date of mailing of the  
9 notice; and

10           WHEREAS, Rouzbeh Javaherian did not submit a written request for hearing within ten (10)  
11 calendar days of the date of mailing of the notice; and

12           WHEREAS, the Administrative Director is required to suspend any physician, practitioner, or  
13 provider pursuant to Labor Code section 139.21 and Title 8, California Code of Regulations section  
14 9788.2, after thirty (30) days from the date the notice was mailed, unless the physician, practitioner, or  
15 provider submits a written request for a hearing within ten (10) calendar days of the date of mailing of  
16 the notice;

17           **IT IS HEREBY ORDERED** that Rouzbeh Javaherian is hereby suspended from participating in  
18 the workers' compensation system as a physician, practitioner, or provider.
