**ORDER OF SUSPENSION**

9                   WHEREAS, Labor Code section 139.21(a)(1)(A) requires the Administrative Director to  
10 suspend any physician, practitioner, or provider from participating in the workers'  
11 compensation system as a physician, practitioner, or provider if the individual has been  
12 convicted of any felony or misdemeanor described in Labor Code section 139.21(a)(1)(A); and

13                   WHEREAS, on or about May 13, 2021, Respondent Seo Myong Yang pled guilty to or  
14 was found guilty of one or more felonies or misdemeanors described in Labor Code section  
15 139.21(a)(1)(A) in the Superior Court of California, County of Stanislaus; and

16                   WHEREAS, Labor Code section 139.21(a)(1)(C) requires the Administrative Director to  
17 suspend any physician, practitioner, or provider from participating in the workers'  
18 compensation system as a physician, practitioner, or provider whose license, certification or  
19 approval to provide health care services has been surrendered or revoked; and

20                   WHEREAS, on or about April 15, 2022, Seo Myong Yang's license, certification or  
21 approval to provide health care services was surrendered or revoked by the California Medical  
22 Board, Department of Consumer Affairs State of California; and

23                   WHEREAS, on or about January 10, 2023, the Administrative Director mailed to Seo  
24 Myong Yang a written notice of the right to a hearing regarding the suspension and the  
25 procedure to follow to request a hearing, as provided in Labor Code section 139.21(b)(2) and  
26 California Code of Regulations, title 8, section 9788.1; and

27                   WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of  
28 Regulations, title 8, section 9788.1(d), the written notice advised Seo Myong Yang that the  
suspension would start thirty (30) calendar days after the date of mailing of written not unless

1 Seo Myong Yang submitted a written request for a hearing within ten (10) calendar days of the  
2 date of mailing of the notice; and

3 WHEREAS, Seo Myong Yang did not submit a written request for hearing within ten  
4 (10) calendar days of the date of mailing of the notice; and

5 WHEREAS, the Administrative Director is required to suspend any physician,  
6 practitioner, or provider pursuant to Labor Code section 139.21 and title 8, California Code of  
7 Regulations section 9788.2, after thirty (30) days from the date the notice was mailed, unless  
8 the physician, practitioner, or provider submits a written request for a hearing within ten (10)  
9 calendar days of the date of mailing of the notice;

10 **IT IS HEREBY ORDERED** that Seo Myong Yang is hereby suspended from  
11 participating in the workers' compensation system as a physician, practitioner, or provider.
