**OPINION AND ORDER
DISMISSING PETITION FOR
REMOVAL**

On, January 5, 2021, the workers' compensation administrative law judge (WCJ) issued an Order Granting Change of Venue in ADJ13280100. On January 20, 2021, defendant filed a Petition for Removal in cases ADJ13280100, ADJ13764415, ADJ13764447, and ADJ13764436. Therein, defendant asserts a violation of due process only as to the Order Granting Change of Venue in ADJ13280100. Defendant does not assert any issues as to cases ADJ13764415, ADJ13764447, and ADJ13764436. The WCJ issued an Order Vacating and Rescinding Order Granting Change of Venue in ADJ13280100 on January 20, 2020 rendering defendant's Petition for Removal moot. Moreover, defendant is not aggrieved in cases ADJ13764415, ADJ13764447, and ADJ13764436.

Finally, we call attention to the fact that the name of the applicant, date of birth, and address in ADJ13280100 are different than the name of the applicant, date of birth, and address ADJ13764447, ADJ13764436, and ADJ13764415. The parties and the WCJ should clarify these discrepancies before these cases proceed further.

Accordingly, we will dismiss the Petition for Removal.

For the foregoing reasons,

IT IS ORDERED that the Petition for Removal is **DISMISSED**.
