Chief Eric Rood also discussed the Public Works rule-making package. He stated that this package received a large amount of public comments. The 399 was signed by last year's chair Commissioner Buckhorn and also signed off by Commissioner Hussy as financial officer to allow us to begin the process with office of administrative law. Chief Rood stated that as we were getting ready to file the package with office of administrative law, we were advised that the 399 still needed the Department of Finance signature. It was then elevated to Labor and Workforce Development Agency to specifically to look at the 399. Labor Agency is currently conducting a review. This signed package needs to be signed and due by January 2021.
