He stated that we have made improvements on our websites. We had to revamp the women and construction page that we had on our website.

And as you go in there now it is. You know we're continually trying to refine it. There's a bigger project on the website project as we are updating and improving the whole thing. He stated that the division of apprenticeship standards (DAS) is a real small division in a very large department.

Chief Rood discussed that DAS updated their mission statement and We also, for the first time in the division's history, created the vision statement as well. So we're now asking this committee to help us make sure we are still on point and do we still have the right vision

Chief Rood discussed that the Division of Apprenticeship Standards (DAS) is soliciting proposals for the Equal Representation in Construction Apprenticeship grant (ERiCA). The funds from this grant will go towards

supportive resources for childcare and outreach and community building for women, non-binary and underserved populations.

He stated that there was a press release that was released and they're extending the application period for an additional 24 hours on Equal Representation in Construction Apprenticeship grant (ERiCA).

Comments were made that the contact person that answers the phones at the local union hall needs to be a person that is a sales person and have an energetic personality. Discussed the impact of a good recruiter at your local union or program is. How important just engaging with the youth who are interested in the program and letting them know that you're interested in what they're trying to accomplish. You're there to help assist them in reaching those goals.

We had a guest speaker who was Jennifer Lim, DIR External Affairs Deputy Director. She is appointed by Governor Newsom. She presented a slideshow presentation to the members of the apprenticeship community that were present. She discussed how we can elevate your messages and what you are trying to promote into the media or the public eye, or gaining more fans and elevating that to the Rock Star status! She talked about events, videos, resources, and what you can do to help promote that. So, thanking the governor, we got an infusion of funds. She stated that Eric so kindly gave her 2 positions dedicated just towards apprenticeships. She encouraged everyone to

follow DIR on social media. We just publish a guide to DIR that really

highlights very nicely apprenticeship standards program. So that is available to

pick up on our website. We will be having those in print. She stated that we

talked about Logos and colors and all those kinds of things, and we have a

brand guide that is going through some revisions. It was said that this brand

guide might help you help brand us and your efforts in spreading the word so

that will be available to you soon. We really want to partner with you so we

can get feedback and get really industry-specific wording and branding to get

more people to provide apprenticeships and spread the word of the learn and

earn a model.
