3. Respondents entered into the attached STIPULATION FOR DEBARMENT.


4. Based on the STIPULATION FOR DEBARMENT, see Paragraph 11, subsection C of the attached SETTLEMENT AGREEMENT AND RELEASE, Respondent USA WALL SYSTEMS, INC. and EDWARD EUGENE BRAMMER shall be ineligible for a period of three years, beginning April 1, 2015, to do either of the following:

- A) Bid on or be awarded a contract for a public works project; or
- B) Perform work as a subcontractor on a public works project as defined as Labor Code sections 1720, 1720.2, and 1720.3.
