

PREDETERMINED INCREASE

CRAFT/CLASSIFICATION:

Laborer and Related Classifications (Building Construction)

LOCALITIES:

All localities within San Diego County

This predetermined increase for the above named craft applies only to the current determination for work being performed on public works projects with bid advertisement dates on or after **September 1, 2023**, until this determination is superseded by a new determination or a predetermined increase modification notice becomes effective.

Determination SD-23-102-4-2023-2 is currently in effect and expires on June 30, 2024**.

Effective on July 1, 2024, there will be an increase of \$3.52 to wages and/or employer payments.

Effective on July 1, 2025, there will be an increase of \$3.63 to wages and/or employer payments.

There will be no further increases applicable to this determination.

LABORER: Building Construction – Group 2

Determination SD-23-102-4-2023-2 is currently in effect and expires on June 30, 2024**.

Effective on July 1, 2024, there will be an increase of \$3.55 to wages and/or employer payments.

Effective on July 1, 2025, there will be an increase of \$3.66 to wages and/or employer payments.

There will be no further increases applicable to this determination.

LABORER: Building Construction – Group 3

Determination SD-23-102-4-2023-2 is currently in effect and expires on June 30, 2024**.

Effective on July 1, 2024, there will be an increase of \$3.59 to wages and/or employer payments.

Effective on July 1, 2025, there will be an increase of \$3.69 to wages and/or employer payments.

There will be no further increases applicable to this determination.

LABORER: Building Construction – Group 4

Determination SD-23-102-4-2023-2 is currently in effect and expires on June 30, 2024**.

Effective on July 1, 2024, there will be an increase of \$3.87 to wages and/or employer payments.

Effective on July 1, 2025, there will be an increase of \$3.97 to wages and/or employer payments.

There will be no further increases applicable to this determination.

LABORER: Building Construction – Group 5

Determination SD-23-102-4-2023-2 is currently in effect and expires on June 30, 2024**.

Effective on July 1, 2024, there will be an increase of \$3.06 to wages and/or employer payments.

Effective on July 1, 2025, there will be an increase of \$3.09 to wages and/or employer payments.
