8 ORDER OF SUSPENSION

9  
10 WHEREAS, Labor Code section 139.21(a)(1)(A) requires the Administrative Director to  
11 suspend any physician, practitioner, or provider from participating in the workers' compensation system  
12 as a physician, practitioner, or provider if the individual has been convicted of any felony or  
13 misdemeanor described in Labor Code section 139.21(a)(1)(A); and

14 WHEREAS, on or about March 25, 2019, Venkat Aachi pled guilty to or was found guilty of one  
15 or more felonies or misdemeanors described in Labor Code section 139.21(a)(1)(A) in the United States  
16 District Court, Northern District of California, San Jose Division; and

17 WHEREAS, on or about May 28, 2019, the Administrative Director mailed to Venkat Aachi a  
18 written notice of the right to a hearing regarding the suspension and the procedure to follow to request a  
19 hearing, as provided in Labor Code section 139.21(b)(2) and California Code of Regulations, title 8,  
20 section 9788.1; and

21 WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of Regulations,  
22 title 8, section 9788.1(d), the written notice advised Venkat Aachi that the suspension would start thirty  
23 (30) calendar days after the date of mailing of written notice, unless Venkat Aachi submitted a written  
24 request for a hearing within ten (10) calendar days of the date of mailing of the notice; and


25 WHEREAS, Venkat Aachi did not submit a written request for hearing within ten (10) calendar  
26 days of the date of mailing of the notice; and

27 WHEREAS, the Administrative Director is required to suspend any physician, practitioner, or  
28 provider pursuant to Labor Code section 139.21 and Title 8, California Code of Regulations section  
9788.2, after thirty (30) days from the date the notice was mailed, unless the physician, practitioner, or

1 provider submits a written request for a hearing within ten (10) calendar days of the date of mailing of  
2 the notice;

3 **IT IS HEREBY ORDERED** that Venkat Aachi is hereby suspended from participating in the  
4 workers' compensation system as a physician, practitioner, or provider.
