ORDER OF SUSPENSION

WHEREAS, Labor Code section 139.21(a)(1)(C) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider whose license, certification, or approval to provide health care services has been surrendered or revoked; and

WHEREAS, on or about March 22, 2023 Melissa Maria Carr's, aka Melissa Marie Dugan, aka Melissa Marie Clark, aka Melissa Marie Cunningham (Melissa Carr) license, certification, or approval to provide health care services was surrendered or revoked by the Board of Registered Nursing, Department of Consumer Affairs; and

WHEREAS, on or about May 21, 2024, the Administrative Director mailed to Melissa Carr a written notice of the right to a hearing regarding the suspension and the procedure to follow to request a hearing, as provided in Labor Code section 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1; and

WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1(d), the written notice advised Melissa Carr that the suspension would start thirty (30) calendar days after the date of mailing of written notice, unless Melissa Carr submitted a written request for a hearing within ten (10) calendar days of the date of mailing of the notice; and

1 WHEREAS, Melissa Carr did not submit a written request for hearing within ten (10)
2 calendar days of the date of mailing of the notice; and

3 WHEREAS, the Administrative Director is required to suspend any physician,
4 practitioner, or provider pursuant to Labor Code section 139.21 and California Code of
5 Regulations, title 8, section 9788.2, after thirty (30) days from the date the notice was
6 mailed, unless the physician, practitioner, or provider submits a written request for a
7 hearing within ten (10) calendar days of the date of mail of the notice;

8 **IT IS HEREBY ORDERED** that Respondent Melissa Carr is hereby suspended from
9 participating in the workers' compensation system as a physician, practitioner, or provider.
