**ORDER OF SUSPENSION**

11 WHEREAS, Labor Code section 139.21(a)(1)(A) requires the Administrative Director  
12 to suspend any physician, practitioner, or provider from participating in the workers'  
13 compensation system as a physician, practitioner, or provider if the individual has been  
14 convicted of any felony or misdemeanor described in Labor Code section 139.21(a)(1)(A);  
15 and

16 WHEREAS, on or about November 22, 2022, Respondent Lindsay Marie Clark pled  
17 guilty to or was found guilty of one or more felonies or misdemeanors described in Labor  
18 Code section 139.21(a)(1)(A) in the United States District Court, Northern District of  
19 California; and

20 WHEREAS, on or about October 11, 2023, the Administrative Director mailed to  
21 Lindsay Marie Clark a written notice of the right to a hearing regarding the suspension and  
22 the procedure to follow to request a hearing, as provided in Labor Code section  
23 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1; and

24 WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of  
25 Regulations, title 8, section 9788.1(d), the written notice advised Lindsay Marie Clark that  
26 the suspension would start thirty (30) calendar days after the date of mailing of written  
27 notice, unless Lindsay Marie Clark submitted a written request for a hearing within ten (10)  
28 calendar days of the date of mailing of the notice; and

1           WHEREAS, Lindsay Marie Clark did not submit a written request for hearing within  
2 ten (10) calendar days of the date of mailing of the notice; and

3           WHEREAS, the Administrative Director is required to suspend any physician,  
4 practitioner, or provider pursuant to Labor Code section 139.21 and California Code of  
5 Regulations, title 8, section 9788.2, after thirty (30) days from the date the notice was  
6 mailed, unless the physician, practitioner, or provider submits a written request for a  
7 hearing within ten (10) calendar days of the date of mail of the notice;

8           **IT IS HEREBY ORDERED** that Respondent Lindsay Marie Clark is hereby  
9 suspended from participating in the workers' compensation system as a physician,  
10 practitioner, or provider.
