**ORDER OF SUSPENSION**

WHEREAS, Labor Code section 139.21(a)(1)(A) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider if the individual has been convicted of any felony or misdemeanor described in Labor Code section 139.21(a)(1)(A); and

WHEREAS, on or about November 3, 2021, Respondent Joshua Michael-Jame Dockery, aka Joshua Michael-James Dockery (Joshua Dockery) pled guilty to or was found guilty of one or more felonies or misdemeanors described in Labor Code section 139.21(a)(1)(A) in the Superior Court of California, County of Kings; and

WHEREAS, Labor Code section 139.21(a)(1)(C) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider whose license, certification, or approval to provide health care services has been surrendered or revoked; and

WHEREAS, on or about April 7, 2023, Joshua Dockery's license, certification, or approval to provide health care services was surrendered or revoked by the Board of Registered Nursing, Department of Consumer Affairs]; and

WHEREAS, on or about June 4, 2024, the Administrative Director mailed to Joshua Dockery a written notice of the right to a hearing regarding the suspension and the

1 procedure to follow to request a hearing, as provided in Labor Code section 139.21(b)(2)  
2 and California Code of Regulations, title 8, section 9788.1; and

3 WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of  
4 Regulations, title 8, section 9788.1(d), the written notice advised Joshua Dockery that the  
5 suspension would start thirty (30) calendar days after the date of mailing of written notice,  
6 unless Joshua Dockery submitted a written request for a hearing within ten (10) calendar  
7 days of the date of mailing of the notice; and

8 WHEREAS, Joshua Dockery did not submit a written request for hearing within ten  
9 (10) calendar days of the date of mailing of the notice; and

10 WHEREAS, the Administrative Director is required to suspend any physician,  
11 practitioner, or provider pursuant to Labor Code section 139.21 and California Code of  
12 Regulations, title 8, section 9788.2, after thirty (30) days from the date the notice was  
13 mailed, unless the physician, practitioner, or provider submits a written request for a  
14 hearing within ten (10) calendar days of the date of mail of the notice;

15 **IT IS HEREBY ORDERED** that Respondent Joshua Dockery is hereby suspended  
16 from participating in the workers' compensation system as a physician, practitioner, or  
17 provider.
