ORDER OF SUSPENSION

11 WHEREAS, Labor Code section 139.21(a)(1)(C) requires the Administrative Director
12 to suspend any physician, practitioner, or provider from participating in the workers'
13 compensation system as a physician, practitioner, or provider whose license, certification,
14 or approval to provide health care services has been surrendered or revoked; and

15 WHEREAS, on or about March 24, 2023, Respondent Ashley N. Galbraith's license,
16 certification, or approval to provide health care services was surrendered or revoked by the
17 California Board of Registered Nursing, Department of Consumer Affairs; and

18 WHEREAS, on or about December 13, 2023, the Administrative Director mailed to
19 Ashley N. Galbraith a written notice of the right to a hearing regarding the suspension and
20 the procedure to follow to request a hearing, as provided in Labor Code section
21 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1; and

22 WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of
23 Regulations, title 8, section 9788.1(d), the written notice advised Ashley N. Galbraith that
24 the suspension would start thirty (30) calendar days after the date of mailing of written
25 notice, unless Ashley N. Galbraith submitted a written request for a hearing within ten (10)
26 calendar days of the date of mailing of the notice; and

27 WHEREAS, Ashley N. Galbraith did not submit a written request for hearing within
28 ten (10) calendar days of the date of mailing of the notice; and

1 WHEREAS, the Administrative Director is required to suspend any physician,
2 practitioner, or provider pursuant to Labor Code section 139.21 and California Code of
3 Regulations, title 8, section 9788.2, after thirty (30) days from the date the notice was
4 mailed, unless the physician, practitioner, or provider submits a written request for a
5 hearing within ten (10) calendar days of the date of mail of the notice;

6 **IT IS HEREBY ORDERED** that Respondent Ashley N. Galbraith is hereby
7 suspended from participating in the workers' compensation system as a physician,
8 practitioner, or provider.
