11 ORDER OF SUSPENSION

12 WHEREAS, Labor Code section 139.21(a)(1)(A) requires the Administrative Director
13 to suspend any physician, practitioner, or provider from participating in the workers'
14 compensation system as a physician, practitioner, or provider if the individual has been
15 convicted of any felony or misdemeanor described in Labor Code section 139.21(a)(1)(A);
16 and

17 WHEREAS, on or about December 14, 2023, Respondent Jamen Oliver Griffith
18 (Jamen Griffith) pled guilty to or was found guilty of one or more felonies or misdemeanors
19 described in Labor Code section 139.21(a)(1)(A) in the United States District Court, Central
20 District of California; and

21 WHEREAS, on or about May 21, 2024, the Administrative Director mailed to Jamen
22 Griffith a written notice of the right to a hearing regarding the suspension and the procedure
23 to follow to request a hearing, as provided in Labor Code section 139.21(b)(2) and
24 California Code of Regulations, title 8, section 9788.1; and

25 WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of
26 Regulations, title 8, section 9788.1(d), the written notice advised Jamen Griffith that the
27 suspension would start thirty (30) calendar days after the date of mailing of written notice,
28 unless Jamen Griffith submitted a written request for a hearing within ten (10) calendar
days of the date of mailing of the notice; and

1 WHEREAS, Jamen Griffith did not submit a written request for hearing within ten
2 (10) calendar days of the date of mailing of the notice; and

3 WHEREAS, the Administrative Director is required to suspend any physician,
4 practitioner, or provider pursuant to Labor Code section 139.21 and California Code of
5 Regulations, title 8, section 9788.2, after thirty (30) days from the date the notice was
6 mailed, unless the physician, practitioner, or provider submits a written request for a
7 hearing within ten (10) calendar days of the date of mail of the notice;

8 **IT IS HEREBY ORDERED** that Respondent Jamen Griffith is hereby suspended
9 from participating in the workers' compensation system as a physician, practitioner, or
10 provider.
