ORDER OF SUSPENSION

WHEREAS, Labor Code section 139.21(a)(1)(C) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider whose license, certification, or approval to provide health care services has been surrendered or revoked; and

WHEREAS, on or about May 24, 2023, Respondent Cynthia Hutchins-Matthews's, aka Cynthia Latrice Hutchins (Cynthia Hutchins-Matthews) license, certification, or approval to provide health care services was surrendered or revoked by the Board of Registered Nursing, Department of Consumer Affairs; and

WHEREAS, on or about May 21, 2024, the Administrative Director mailed to Cynthia Hutchins-Matthews a written notice of the right to a hearing regarding the suspension and the procedure to follow to request a hearing, as provided in Labor Code section 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1; and

WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1(d), the written notice advised Cynthia Hutchins-Matthews that the suspension would start thirty (30) calendar days after the date of mailing of written notice, unless Cynthia Hutchins-Matthews submitted a written request for a hearing within ten (10) calendar days of the date of mailing of the notice; and

1 WHEREAS, Cynthia Hutchins-Matthews did not submit a written request for hearing
2 within ten (10) calendar days of the date of mailing of the notice; and

3 WHEREAS, the Administrative Director is required to suspend any physician,
4 practitioner, or provider pursuant to Labor Code section 139.21 and California Code of
5 Regulations, title 8, section 9788.2, after thirty (30) days from the date the notice was
6 mailed, unless the physician, practitioner, or provider submits a written request for a
7 hearing within ten (10) calendar days of the date of mail of the notice;

8 **IT IS HEREBY ORDERED** that Respondent Cynthia Hutchins-Matthews is hereby
9 suspended from participating in the workers' compensation system as a physician,
10 practitioner, or provider.
