ORDER OF SUSPENSION

WHEREAS, Labor Code section 139.21(a)(1)(A) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider if the individual has been convicted of any felony or misdemeanor described in Labor Code section 139.21(a)(1)(A); and

WHEREAS, on or about January 4, 2022, Respondent Tamala Denise McDonald (Tamala McDonald) pled guilty to or was found guilty of one or more felonies or misdemeanors described in Labor Code section 139.21(a)(1)(A); and

WHEREAS, Labor Code section 139.21(a)(1)(B) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider who has been suspended, due to fraud or abuse, from the federal Medicare or Medicaid programs; and

WHEREAS, Tamala McDonald was suspended, due to fraud or abuse, from the federal Medicare or Medicaid programs; and

WHEREAS, on or about June 11, 2024, the Administrative Director mailed to Tamala McDonald a written notice of the right to a hearing regarding the suspension and the procedure to follow to request a hearing, as provided in Labor Code section 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1; and

1 WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of
2 Regulations, title 8, section 9788.1(d), the written notice advised Tamala McDonald that the
3 suspension would start thirty (30) calendar days after the date of mailing of written notice,
4 unless Tamala McDonald submitted a written request for a hearing within ten (10) calendar
5 days of the date of mailing of the notice; and

6 WHEREAS, Tamala McDonald did not submit a written request for hearing within ten
7 (10) calendar days of the date of mailing of the notice; and

8 WHEREAS, the Administrative Director is required to suspend any physician,
9 practitioner, or provider pursuant to Labor Code section 139.21 and California Code of
10 Regulations, title 8, section 9788.2, after thirty (30) days from the date the notice was
11 mailed, unless the physician, practitioner, or provider submits a written request for a
12 hearing within ten (10) calendar days of the date of mail of the notice;

13 **IT IS HEREBY ORDERED** that Respondent Tamala McDonald is hereby suspended
14 from participating in the workers' compensation system as a physician, practitioner, or
15 provider.
