ORDER OF SUSPENSION

6 SHAUNTELLE L. MCPHEETERS,

9 WHEREAS, Labor Code section 139.21(a)(1)(C) requires the Administrative Director to  
10 suspend any physician, practitioner, or provider from participating in the workers'  
11 compensation system as a physician, practitioner, or provider whose license, certification or  
12 approval to provide health care services has been surrendered or revoked; and

13 WHEREAS, on or about November 9, 2016, Respondent Shauntelle L. McPheeters'  
14 (Shauntelle McPheeters) license, certification or approval to provide health care services was  
15 surrendered or revoked by the California Board of Registered Nurses, Department of  
16 Consumer Affairs; and

17 WHEREAS, on or about May 1, 2023, the Administrative Director mailed to Shauntelle  
18 McPheeters a written notice of the right to a hearing regarding the suspension and the  
19 procedure to follow to request a hearing, as provided in Labor Code section 139.21(b)(2) and  
20 California Code of Regulations, title 8, section 9788.1; and

21 WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of  
22 Regulations, title 8, section 9788.1(d), the written notice advised Shauntelle McPheeters that  
23 the suspension would start thirty (30) calendar days after the date of mailing of written notice,  
24 unless Shauntelle McPheeters submitted a written request for a hearing within ten (10)  
25 calendar days of the date of mailing of the notice; and

26 WHEREAS, Shauntelle McPheeters did not submit a written request for hearing within  
27 ten (10) calendar days of the date of mailing of the notice; and

1           WHEREAS, the Administrative Director is required to suspend any physician,  
2 practitioner, or provider pursuant to Labor Code section 139.21 and California Code of  
3 Regulations, title 8, section 9788.2, after thirty (30) days from the date the notice was mailed,  
4 unless the physician, practitioner, or provider submits a written request for a hearing within ten  
5 (10) calendar days of the date of mailing of the notice;

6           **IT IS HEREBY ORDERED** that Shauntelle McPheeters is hereby suspended from  
7 participating in the workers' compensation system as a physician, practitioner, or provider.
