ORDER OF SUSPENSION

WHEREAS, Labor Code section 139.21(a)(1)(A) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider if the individual has been convicted of any felony or misdemeanor described in Labor Code section 139.21(a)(1)(A); and

WHEREAS, on or about February 4, 2016, Respondent Kevin Meehan pled guilty to or was found guilty of one or more felonies or misdemeanors described in Labor Code section 139.21(a)(1)(A) in the Superior Court of the State of California, County of Kings; and

WHEREAS, Labor Code section 139.21(a)(1)(B) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider who has been suspended, due to fraud or abuse, from the federal Medicare or Medicaid programs; and

WHEREAS, Kevin Meehan was suspended, due to fraud or abuse, from the federal Medicare or Medicaid programs; and

WHEREAS, Labor Code section 139.21(a)(1)(C) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider whose license, certification or approval to provide health care services has been surrendered or revoked; and

WHEREAS, on or about November 10, 2016, Kevin Meehan's license, certification or approval to provide health care services was surrendered or revoked by the California Board of

1 Vocational Nursing and Psychiatric Technicians, Department of Consumer Affairs; and

2 WHEREAS, on or about December 1, 2022, the Administrative Director mailed to Kevin
3 Meehan a written notice of the right to a hearing regarding the suspension and the procedure
4 to follow to request a hearing, as provided in Labor Code section 139.21(b)(2) and California
5 Code of Regulations, title 8, section 9788.1; and

6 WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of
7 Regulations, title 8, section 9788.1(d), the written notice advised Kevin Meehan that the
8 suspension would start thirty (30) calendar days after the date of mailing of written notice,
9 unless Kevin Meehan submitted a written request for a hearing within ten (10) calendar days of
10 the date of mailing of the notice; and

11 WHEREAS, Kevin Meehan did not submit a written request for hearing within ten (10)
12 calendar days of the date of mailing of the notice; and

13 WHEREAS, the Administrative Director is required to suspend any physician,
14 practitioner, or provider pursuant to Labor Code section 139.21 and California Code of
15 Regulations, title 8, section 9788.2, after thirty (30) days from the date the notice was mailed,
16 unless the physician, practitioner, or provider submits a written request for a hearing within ten
17 (10) calendar days of the date of mailing of the notice;

18 **IT IS HEREBY ORDERED** that Respondent Kevin Meehan is hereby suspended from
19 participating in the workers' compensation system as a physician, practitioner, or provider.
