ORDER OF SUSPENSION

11 WHEREAS, Labor Code section 139.21(a)(1)(C) requires the Administrative Director
12 to suspend any physician, practitioner, or provider from participating in the workers'
13 compensation system as a physician, practitioner, or provider whose license, certification,
14 or approval to provide health care services has been surrendered or revoked; and

15 WHEREAS, on or about December 7, 2022, Respondent Daisy Servillas', aka Daisy
16 Servillas-Reyes (Daisy Servillas) license, certification, or approval to provide health care
17 services was surrendered or revoked by the Board of Registered Nursing, Department of
18 Consumer Affairs; and

19 WHEREAS, on or about March 25, 2024, the Administrative Director mailed to Daisy
20 Servillas a written notice of the right to a hearing regarding the suspension and the
21 procedure to follow to request a hearing, as provided in Labor Code section 139.21(b)(2)
22 and California Code of Regulations, title 8, section 9788.1; and

23 WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of
24 Regulations, title 8, section 9788.1(d), the written notice advised Daisy Servillas that the
25 suspension would start thirty (30) calendar days after the date of mailing of written notice,
26 unless Daisy Servillas submitted a written request for a hearing within ten (10) calendar
27 days of the date of mailing of the notice; and

1 WHEREAS, Daisy Servillas did not submit a written request for hearing within ten
2 (10) calendar days of the date of mailing of the notice; and

3 WHEREAS, the Administrative Director is required to suspend any physician,
4 practitioner, or provider pursuant to Labor Code section 139.21 and California Code of
5 Regulations, title 8, section 9788.2, after thirty (30) days from the date the notice was
6 mailed, unless the physician, practitioner, or provider submits a written request for a
7 hearing within ten (10) calendar days of the date of mail of the notice;

8 **IT IS HEREBY ORDERED** that Respondent Daisy Servillas is hereby suspended
9 from participating in the workers' compensation system as a physician, practitioner, or
10 provider.
