**ORDER OF SUSPENSION**

WHEREAS, Labor Code section 139.21(a)(1)(A) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider if the individual has been convicted of any felony or misdemeanor described in Labor Code section 139.21(a)(1)(A); and

WHEREAS, on or about April 6, 2022, Respondent Paul Henry Zwetsloot (Paul Zwetsloot) pled guilty to or was found guilty of one or more felonies or misdemeanors described in Labor Code section 139.21(a)(1)(A) in the Superior Court of California, County of Siskiyou; and

WHEREAS, Labor Code section 139.21(a)(1)(B) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider who has been suspended, due to fraud or abuse, from the federal Medicare or Medicaid programs; and

WHEREAS, Paul Zwetsloot was suspended, due to fraud or abuse, from the federal Medicare or Medicaid programs; and

WHEREAS, Labor Code section 139.21(a)(1)(C) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider whose license, certification, or approval to provide health care services has been surrendered or revoked; and

1           WHEREAS, on or about June 13, 2022, Paul Zwetsloot's license, certification, or  
2 approval to provide health care services was surrendered or revoked by the California Physical  
3 Therapy Board, Department of Consumer Affairs; and

4           WHEREAS, on or about March 16, 2023, the Administrative Director mailed to Paul  
5 Zwetsloot a written notice of the right to a hearing regarding the suspension and the procedure  
6 to follow to request a hearing, as provided in Labor Code section 139.21(b)(2) and California  
7 Code of Regulations, title 8, section 9788.1; and

8           WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of  
9 Regulations, title 8, section 9788.1(d), the written notice advised Paul Zwetsloot that the  
10 suspension would start thirty (30) calendar days after the date of mailing of written notice,  
11 unless Paul Zwetsloot submitted a written request for a hearing within ten (10) calendar days  
12 of the date of mailing of the notice; and

13           WHEREAS, Paul Zwetsloot did not submit a written request for hearing within ten (10)  
14 calendar days of the date of mailing of the notice; and

15           WHEREAS, the Administrative Director is required to suspend any physician,  
16 practitioner, or provider pursuant to Labor Code section 139.21 and California Code of  
17 Regulations, title 8, section 9788.2, after thirty (30) days from the date the notice was mailed,  
18 unless the physician, practitioner, or provider submits a written request for a hearing within ten  
19 (10) calendar days of the date of mailing of the notice;

20           **IT IS HEREBY ORDERED** that Paul Zwetsloot is hereby suspended from participating  
21 in the workers' compensation system as a physician, practitioner, or provider.
