Notice of Modification of Text of Amendments to the Conflict of Interest Code of the Department of Industrial Relations

California Code of Regulations, Title 8, Division 1, Chapter 8, Subchapter 5, Section 17000 and Appendix

Pursuant to the requirements of section 18750(d)(2) of Title 2 of the California Code of Regulations, the Director of the Department of Industrial Relations is providing notice of modifications to the text to the proposed amendments to the Department's Conflict of Interest Code. The modifications are all to the section of the Appendix showing disclosure categories by position, and consist of the inclusion of reporting positions that were inadvertently omitted and the modification of other position descriptions, as follows:

Commission on Health and Safety and Workers' Compensation [CHSWC] –
Add Industrial Relations Counsel – all levels

Division of Occupational Safety & Health –
Modify "Principal Safety Engineer" by deleting qualifier "*Industrial*"
Modify "Senior Safety Engineer" by deleting qualifier "*Industrial*"

Division of Workers' Compensation –
Add Research Manager – all levels
Modify "Senior Special Investigator" by deleting "*Senior*" and adding "(all levels)" so that it now reads "Special Investigator (all levels)"
