**NOTICE OF MODIFICATION TO TEXT OF PROPOSED REGULATIONS  
AND REVISION TO INITIAL STATEMENT OF REASONS**

**Subject Matter of Regulations: Return to Work Supplement Program**

**California Code of Regulations, Title 8, Article 1  
Sections 17300-17310**

**NOTICE IS HEREBY GIVEN** that the Director of Industrial Relations (“Director”), pursuant to rulemaking authority derived from Labor Code sections 54, 55, and 139.48, in order to implement, interpret and make specific sections 139.48 of the Labor Code, proposes to:

- Renumber the proposed regulations from sections 25101 through 25111 to sections 17300 through 17310.
- Modify the text of proposed sections 17301 (formerly 25102), 17302 (formerly 25103), 17303 (formerly 25104), 17307 (formerly 25108), and 17308 (formerly 25109).
- Add Authority and Reference citations to sections 17300 through 17310.

- Revised to add Note with Authority and Reference citations.

- Subdivision (a) is revised to insert the word "Voucher."
- Revised to add Note with Authority and Reference citations.

### **Proposed Section 17303:**

- Revised to require that notice be provided via a cover sheet accompanying the Supplemental Job Displacement Voucher to be prepared by the claims administrator until the Administrative Director of the Division of Workers' Compensation amends the Voucher form to include notice language about the Return-to-Work Supplement and to delete the alternative of insertion of the notice on page 6 of form DWC-AD 10133.32.

- Revised to delete the phrases “from time to time,” to eliminate a potentially vague time reference, and “and or based on consideration of the number of anticipated recipients,” to more clearly comply with the grounds for setting the benefit amount for the Return-to-Work Supplement specified by Labor Code section 139.48.
- Revised to add Note with Authority and Reference citations.
