This predetermined increase for the above named craft applies only to the current determination for work being performed on public works projects with bid advertisement dates on or after September 1, 2009, until this determination is superseded by a new determination or a predetermined increase modification notice becomes effective.

When referencing our prevailing wage determinations, please note that if the prevailing wage rate determination which was in effect on the bid advertisement date of a project has a single asterisk (*) after the expiration date, the rate will be good for the life of the project. However, if a prevailing wage rate determination has double asterisks (**) after the expiration date, the rate must be updated on the following date to reflect the predetermined rate change(s).

TREE TRIMMER: 1st year Climber

Determination C-TT-61-465-5-2009-2 is currently in effect and expires on August 28, 2010**.

Effective August 29, 2010, there will be an increase of \$0.69 to the Basic Hourly Rate and \$0.04 to Vacation/Holidays.

There will be no further increases applicable to this determination.

TREE TRIMMER: 2nd year Climber

Determination C-TT-61-465-5-2009-2 is currently in effect and expires on August 28, 2010**.

Effective August 29, 2010, there will be an increase of \$0.80 to the Basic Hourly Rate and \$0.07 to Vacation/Holidays.

There will be no further increases applicable to this determination.

TREE TRIMMER: Thereafter Climber

Determination C-TT-61-465-5-2009-2 is currently in effect and expires on August 28, 2010**.

Effective August 29, 2010, there will be an increase of \$0.90 to the Basic Hourly Rate and \$0.08 to Vacation/Holidays.

After 7 years of service at this level:

Effective August 29, 2010, there will be an increase of \$0.90 to the Basic Hourly Rate and \$0.10 to Vacation/Holidays.

There will be no further increases applicable to this determination.

TREE TRIMMER: Trainee

Determination C-TT-61-465-5-2009-2 is currently in effect and expires on August 28, 2010**.

Effective August 29, 2010, there will be an increase of \$0.62 to the Basic Hourly Rate and \$0.04 to Vacation/Holidays.

There will be no further increases applicable to this determination.

GROUNDMAN: 1st year

Determination C-TT-61-465-5-2009-2 is currently in effect and expires on August 28, 2010**.

Effective August 29, 2010, there will be an increase of \$0.51 to the Basic Hourly Rate and \$0.03 to Vacation/Holidays.

There will be no further increases applicable to this determination.

GROUNDMAN: Thereafter

Determination C-TT-61-465-5-2009-2 is currently in effect and expires on August 28, 2010**.

Effective August 29, 2010, there will be an increase of \$0.55 to the Basic Hourly Rate and \$0.04 to Vacation/Holidays.

After 8 year of service at this level:

Effective August 29, 2010, there will be an increase of \$0.55 to the Basic Hourly Rate and \$0.06 to Vacation/Holidays.

There will be no further increases applicable to this determination.
