When referencing our prevailing wage determinations, please note that if the prevailing wage rate determination which was in effect on the bid advertisement date of a project has a single asterisk (*) after the expiration date, the rate will be good for the life of the project. However, if a prevailing wage rate determination has double asterisks (**) after the expiration date, the rate must be updated on the following date to reflect the predetermined rate change(s).

**OPERATING ENGINEER; CRANES, PILE DRIVER AND HOISTING EQUIPMENT; TUNNEL; AND,
BUILDING/CONSTRUCTION INSPECTOR AND FIELD SOILS AND MATERIAL TESTER:
All Classifications and All Shifts**

The above Determinations issued on February 22, 2011 will expire on June 30, 2011**.

Effective July 1, 2011, there was an increase of \$1.40 allocated as follows:

- \$0.30 to Basic Hourly Rate
- \$0.50 to Health and Welfare
- \$0.40 to Pension
- \$0.15 to Training
- \$0.05 to Other

Effective July 1, 2012, there will be an increase of \$1.70 allocated as follows:

- \$1.27 to Basic Hourly Rate
- \$0.40 to Pension
- \$0.03 to Supplemental Dues

There will be no further increases applicable to this determination.
