The parties agree to incorporate the then wage and benefit structure negotiated for the given county (reflected in Addendum E) as part of this agreement. The parties are in agreement that the many counties contained within the State of California have different wage rates which are determined by the economics of said counties.

The following parties, Hod Carriers' Union Local No. 166 affiliated with the American Federation of Labor and the Wall and Ceiling Alliance (WACA), on behalf of itself and its' member/employers, after due consideration, voluntarily enter into this Agreement.



Section 5: Subsistence. On jobs sixty (60) miles or more from the jurisdiction of the Union Hiring Hall or the member's home, to the jobsite, the allowance shall be paid at a rate of seventy-five dollars (\$75) for each day worked, or reasonable room and board.
