

SECTION 3. Holidays: New Year's Day, Presidents Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, the Friday following Thanksgiving Day, Christmas Day and Sundays shall be recognized as holidays. All work performed on holidays shall be paid at two (2) times the gross taxable hourly wage rate. All fringe contributions with the exception of vacation pay and Local 104 supplemental pension (see Article X, Section 6), shall be paid at the regular hourly rate. Vacation pay contributions shall be paid at two (2) times the regular hourly rate. The overtime rate for dues check-off is applicable to two (2) times the regular hourly rate but is paid on the

fringe contribution report at the regular hourly rate, the extra one (1) times the regular dues check-off rate shall be added to the employee's base wage. Holidays shall be observed on the date of the occurrence, except that holidays which fall on Saturday shall be observed the previous Friday and holidays which fall on Sunday shall be observed the following Monday.
