ARTICLE 3 TRAVEL AND PARKING

- 15. When an employee is required to move during the day from one job to another job within the territorial jurisdiction of Local 709, he shall be considered to be working and shall receive the current Federal Mileage Reimbursement rate per mile between jobs and shall be reimbursed for all toll expenses upon submission of receipts.
- 16. Employees shall be paid for parking. This parking fee will be paid when an employee submits a parking receipt to the employer. Parking receipts should be turned in weekly with time cards. Reimbursement shall be paid with the following weeks' paycheck.
 - (a) When parking off site is mandated by contract and member is made to walk or ride a shuttle, the member will walk or shuttle to work site on his own time. The member will walk or shuttle back to his vehicle on company time at the end of his shift.
