REGARDING A CORRECTION TO
THE DIRECTOR'S GENERAL PREVAILING WAGE DETERMINATIONS**

Dear Public Official/Other Interested Parties:

CRAFT: Tree Trimmer (High Voltage Clearance)

CLASSIFICATIONS: Tree Trimmer, Trimmer Trainee: Start (0-6 Months), Trimmer Trainee: 6-12 Months, Trimmer Trainee: After 12 Months, Ground person First 6 Months, Ground person After 6 Months

LOCALITIES: Alameda, Alpine, Amador, Butte, Calaveras, Colusa, Contra Costa, El Dorado, Fresno, Glenn, Humboldt, Imperial, Inyo, Kern, Kings, Lake, Lassen, Los Angeles, Madera, Marin, Mariposa, Mendocino, Merced, Mono, Monterey, Napa, Nevada, Orange, Placer, Plumas, Riverside, Sacramento, San Benito, San Bernardino, San Diego, San Francisco, San Joaquin, San Luis Obispo, San Mateo, Santa Barbara, Santa Clara, Santa Cruz, Shasta, Sierra, Solano, Sonoma, Stanislaus, Sutter, Tehama, Trinity, Tulare, Tuolumne, Ventura, Yolo, and Yuba Counties.

DETERMINATIONS: C-TT-2024-2 (REF: 61-1245-12, 61-465-5, 61-465-5A, and 61-47-3)

The predetermined increase scheduled to take effect on January 1, 2025 for the aforementioned classifications has an incorrect allocation. The correct predetermined increase allocation should read as follows:

Effective on January 1, 2025, there is a \$0.12 increase allocated as follows: \$0.25 *increase* to Health & Welfare and \$0.13 **decrease** to Pension.
