Recognized holidays:

Holidays upon which the general prevailing hourly wage rate for Holiday work shall be paid, shall be all holidays in the collective bargaining agreement, applicable to the particular craft, classification, or type of worker employed on the project, which is on file with the Director of Industrial Relations. If the prevailing rate is not based on a collectively bargained rate, the holidays upon which the prevailing rate shall be paid shall be as provided in Section 6700 of the Government Code. Travel and/or subsistence payment:

In accordance with Labor Code Sections 1773.1 and 1773.9, contractors shall make travel and/or subsistence payments to each worker to execute the work. - ^a An amount up to \$38.40 per 8 hour day (\$4.80 per hour) for a maximum of 5 days per week may be deducted for Health and Welfare. The deduction is limited to the first 173.33 hours worked per month. This is in addition to the \$14.31 per hour employer payment for Health and Welfare.
 - ^b The contribution applies to all hours until \$2,179.00 is paid for the month.
 - ^c Includes amounts for sick leave.
 - ^d Add \$0.07 per hour to the basic hourly rate for each yard or portion of yard hauled over 8 yards.
 - ^e \$3.74 after 2 years of service, \$4.14 after 3 years of service, \$5.12 after 5 years of service, \$6.11 after 10 years of service, \$7.09 after 20 years of service.
 - ^f Add \$0.09 per hour to the basic hourly rate for each yard or portion of yard hauled over 10 yards.
 - ^g \$3.76 after 2 years of service, \$4.16 after 3 years of service, \$5.15 after 5 years of service, \$6.14 after 10 years of service, \$7.13 after 20 years of service.
 - ^h \$3.80 after 2 years of service, \$4.20 after 3 years of service, \$5.20 after 5 years of service, \$6.20 after 10 years of service, \$7.20 after 20 years of service.
