Mr. Thomas noted that no members of the public came forward to comment.

### IV. BUSINESS MEETING

Mr. Thomas called the Business Meeting of the Board to order at 5:55 p.m., November 19, 2020, in Suite 350 of the Occupational Safety and Health Standards Board Office, Sacramento, California, via Webex/teleconference, in accordance with Executive Order N-29-20.

## A. REPORTS

## 1. Division Update

Mr. Berg did not have any updates to provide to the Board.

[Item 2, Legislative Update, and item 3, Executive Officer's Report, from the Reports portion of the Business Meeting were presented out of order from what was listed on the agenda. They were presented after the Board voted on item C, Proposed Emergency Safety Orders for Adoption (Gov. Code Sec. 11346.1) of the Business Meeting.]

# B. PROPOSED VARIANCE DECISIONS FOR ADOPTION

# 1. Consent Calendar

Ms. Shupe stated that item E, Department of State Hospitals, OSHSB File No. 19-V-028, and item H, Patton Equities, LLC, OSHSB File No. 20-V-128, on the consent calendar are not ready for the Board's consideration and should be removed from the consent calendar. She said she is aware of no unresolved procedural issues regarding items A-D, F-G, and I-V on the consent calendar, and she believes that those items are ready for the Board's decision on the question of adoption.

### MOTION

A motion was made by Mr. Harrison and seconded by Ms. Burgel to adopt the consent calendar as modified.

A roll call was taken, and all members present voted "aye." The motion passed.

- C. PROPOSED EMERGENCY SAFETY ORDERS FOR ADOPTION (GOV. CODE SEC. 11346.1)
  - 1. TITLE 8: GENERAL INDUSTRY SAFETY ORDERS

Chapter 4, Subchapter 7, New Sections 3205, 3205.1, 3205.2, 3205.3 and 3205.4

**COVID-19 Prevention** 

**Mr. Parker** and **Mr. Berg** summarized the history and purpose of the proposal and indicated that the proposal is now ready for the Board's consideration and vote.

**Ms. Kennedy** asked what gap this regulation is covering that is separate from the gap being covered by AB 685, especially when it comes to retaliation. **Mr. Parker** stated that this regulation will allow the Division to fully enforce AB 685. There are some slight differences in terms of the definition, but they are non-substantive and only there to clarify things. **Mr. Berg** stated that the regulation clarifies some things that were very vague in the bill while remaining consistent.

**Ms. Kennedy** also asked about the scientific basis for using six foot distancing in the workplace. She said that six foot distancing seems appropriate for brief encounters with people, but not for workplaces since workers are working with people for significant amounts of time. **Mr. Berg** stated that the Division does not think six feet is sufficient, but the Division wants to remain consistent with the message that other public health authorities have been issuing for the last several months so as to eliminate further confusion. He said that science has proven that aerosols can transmit COVID over 20 feet, but if the six foot distancing is combined with mask use, which is also required in the regulation, it can significantly reduce the spread.

**Ms. Laszcz-Davis** stated that she is concerned about the comments from stakeholders in the retail, restaurant, school, and hotel industries, and whether or not this regulation will bridge the gap for them. **Mr. Parker** stated that the Division feels it will bridge the gap. The standard by itself will not do that, but the Division's implementation strategy will help provide clarity to employers and workers.

**Mr. Harrison** stated that he is concerned about the timeliness and practical process of approving the rule. He asked Mr. Berg how soon an advisory committee meeting can take place and an amendment be made to the rule. **Mr. Berg** stated that it should happen within four months, as per the Board's instructions. **Mr. Parker** stated that it could be done sooner if warranted, but doing that would shorten the overall length of time that the standard would be in place.

Ms. Stock stated that she would like to see the Division get the advisory committee meeting scheduled within the next month so that the dialogue process can start. It is possible that some of the concerns might be able to be addressed through dialogue and no changes to the rule would be necessary, and having the dialogue process begin soon would help to identify the problems and determine what to do to resolve them. Mr. Parker agreed that having a meeting where the Division could present its resources to stakeholders would be helpful. He said that he would check with Ms. Shupe regarding the requirements for a formal advisory committee and an informal discussion with stakeholders. Ms. Shupe stated that the proposed decision instructs the Board staff to work with the Division to conduct those advisory committees. There is some rigidity regarding what the Division and Board staff can do with the advisory committee once the rule is adopted, but the Board staff and Division will make sure that it is collaborative.

**Mr. Thomas** stated that he would like to see an informational type of meeting or advisory committee meeting start right away.

Ms. Laszcz-Davis stated that she is concerned about how small employers are going to struggle with implementing this regulation. She asked if it would be possible to hold off voting on this proposal and convene an advisory committee meeting during the first week of December so that an advisory committee can discuss it, and then come back with a revised and refined regulation. By doing that, the resulting regulation may be more applicable and clear than what the Board is voting on today.

**Mr. Thomas** stated that having an advisory committee in December is fine, but there is an urgent need for this regulation right now, so the Board should vote on it today. **Ms. Stock** echoed Mr. Thomas's comments. She said that she feels it is unlikely that an advisory committee will be able to happen that quickly, and taking action now is essential to protect workers. She stated that the Division has also indicated that this regulation is needed to help them with enforcement.

**Ms. Burgel** echoed Mr. Thomas's and Ms. Stock's comments. She is glad to see that this proposal is comprehensive and includes engineering and administrative controls, such as ventilation, staggering breaks, and integrating all the guidance that has been promulgated throughout this pandemic. She also supports medical removal and continuation for workers who are sick. The testing protocols may be difficult for employers to implement, especially integrating the ATD standard when working in a complex organization, but it is a good and necessary standard.

**Mr. Harrison** stated that he supports the rule, but he hopes that some of the concerns raised regarding potential conflicts in the language with some of the recently passed legislation will not create any problems with the Office of Administrative Law.

**Ms. Laszcz-Davis** asked Mr. Berg and Mr. Parker how quickly changes can be made to the ETS if an advisory committee is held after the Board adopts the regulation. If it will be three to five months before changes are implemented, that is not adequate, and some of the requirements in this regulation are so confusing that the confusion will keep them from complying. If changes can be made after the rule is adopted, the Division should begin

working on that right away so employers are able to comply.

**Ms. Stock** stated that she is also concerned about the stories of employer retaliation that she has heard, and she hopes that retaliation will be addressed during the advisory committee process.

**Ms. Kennedy** asked if this regulation oversteps the Board's authority, especially regarding removal of an employee for 14 days who has not been tested and protecting their wages. **Mr. Berg** and **Ms. Shupe** stated that legal counsel had been consulted and that this proposal does not overstep the Board's authority.

# **MOTION**

A motion was made by Ms. Burgel and seconded by Mr. Harrison that the Board adopt the proposal.

A roll call was taken, and all members present voted "aye." The motion passed.

# A. REPORTS (Continued)

# 2. Legislative Update

Ms. Shupe stated that the Legislature is in recess and will resume on January 4, 2021, and Legislative Updates will resume at that time.

### 3. Executive Officer's Report

Ms. Shupe stated that the COVID-19 Prevention ETS rulemaking package will be taken to the Office of Administrative Law (OAL) tomorrow, and that will trigger their 10-day review of the rulemaking. Once it has been uploaded to their "Emergency Regulations Under Review" page on their website, the public will have five calendar days to submit their comments directly to OAL. Instructions on how to submit comments to OAL are provided on their website, as well as in the Notice of Proposed Emergency Action that is posted on the Board's website.

At next month's meeting, the Board will vote on a proposed decision for Petition 580, as well as version 2.0 of the Protection from Wildfire Smoke regulation.

# B. CLOSED SESSION

The need did not develop for the Board to hold a Closed Session at this time.
