

## Landscape & Irrigation PipeFitter Minimum Industry Criteria O-Net Code 47-2152.01 L

#### 1. Length of Training:

Length of Training for a landscape & irrigation fitter shall be comprised of a minimum of 5 years equaling 9000 hours and 720 hours of R.S.I

#### 2. Related Supplemental Instruction:

See appendix A.

#### 3. On the Job Training:

See works processes appendix B.

### 4. Competency Testing:

All apprentices shall pass course competency tests based on related supplemental Instruction before being advanced to the next level

#### 5. Completion Percentages:

Program Sponsors should show a graduation rate of 25% of all apprentices Indentured into their program that satisfactorily complete the full first year following the finish of the probationary period.

## 6. Green Training:

for landscape & irrigation will include typical course topics and community college Green Build Education Group Courses and curriculum or similar program which includes sustainable landscaping principles, xeriscaping design and installation along with efficient design, plantings and irrigation.


