- Counsel Sotivear Sim clarifies that DLSE also has discretion to consider hours worked not under a C-10 contractor for special cases (i.e. Military contractor work, out of country electrical work, etc.) Angela confirms her understanding.
- b. Anthony Wietek asks for approximate timing on when approval letters will be sent. Melinda Davis confirms that they will be sent out no later than tomorrow.
- c. Emilio Mendez requests guidance on what to do as his school (#195) is losing its primary instructor for the electrician program and wants to know if there is a process on DLSE's end for bringing on a new instructor. Zakiya Ali answers that those types of processes are through the Department of Education, not through DLSE. However, DLSE will update school/instructor information via written request. Zakiya demonstrates how to look up approved school information on DLSE's database via screenshare. The ECUinfo email is provided for any update requests.
- d. Nicole Lewis asks about updates to curriculums based on most recent NEC Code book (2023). Melinda Davis advises that 3rd party exam provider PSI will start reviewing and updating to the 2023 NEC in August of 2025. Dan Bierly clarifies that no one is behind re: the 2023 codebook. Rather, the implementation of these codes is on a 3-year cycle. The new codebook will go into full effect in 2026, three years after it was released. Nicole Lewis confirms understanding.
- e. Elvia Barba asks if new schools can begin offering the electrical program now or if they must wait until receiving approval letter. Melinda advises that it is best to wait for the approval letter but that ideally, they will be sent out today (6/4/25) or at the latest, tomorrow (6/5/2025).
- f. Jason Bates asks if there will be a meeting in August to discuss switch to 2023 NEC. Melinda advises that PSI will be reaching out to SMEs at that time. Garrett Greer asks to be included on SME list for contact by PSI. Melinda asks if anyone else wishes to be included on this list. Others who request to be added: Dominique Mitchell, Scott Mayo, Sagit Ploof, Jason Bates.

Melinda states next ECCC meeting will be set for some time in October or November and if that timing doesn't work for any members, please let DLSE know via ECUinfo email.
