

PREDETERMINED INCREASE

CRAFT/CLASSIFICATION:

Cement Mason: Engineering Construction and Building Construction (Buildings Type I-V)

DETERMINATIONS:

SD-23-203-3-2016-1 and SD-23-203-3-2016-1A

LOCALITIES:

All localities within San Diego County

This predetermined increase for the above named craft applies only to the current determination for work being performed on public works projects with bid advertisement dates on or after September 1, 2016, until this determination is superseded by a new determination or a predetermined increase modification notice becomes effective.

Determination SD-23-203-3-2016-1 is currently in effect and expires on December 31, 2016**.

Effective on January 1, 2017, there will be an increase in the amount of \$1.00 to be allocated to the Basic Hourly Rate.

Effective on July 1, 2017, there will be an increase in the amount of \$1.10 to Pension and \$1.00 to the Basic Hourly Rate.

Effective on January 1, 2018, there will be an increase in the amount of \$0.50 to be allocated to the Basic Hourly Rate.

Effective on July 1, 2018, there will be an increase in the amount of \$2.10 to be allocated as follows: \$0.25 to Health and Welfare, \$1.10 to Pension, \$0.60 to Vacation/Holiday and \$0.15 to Other (Supplemental Dues).

Effective on January 1, 2019, there will be an increase in the amount of \$0.50 allocated to the Basic Hourly Rate.

There will be no further increases applicable to this determination

CEMENT MASON: BUILDING CONSTRUCTION (BUILDING TYPES I-V)

Determination SD-23-203-3-2016-1A is currently in effect and expires on December 31, 2016**.

Effective on January 1, 2017, there will be an increase in the amount of \$1.10 to be allocated to the Basic Hourly Rate.

Effective on July 1, 2017, there will be an increase in the amount of \$1.10 to Pension and \$1.40 to the Basic Hourly Rate.

Effective on July 1, 2018, there will be an increase in the amount of \$2.50 to be allocated as follows: \$0.25 to Health and Welfare, \$1.10 to Pension, \$1.00 to Vacation/Holiday and \$0.15 to Other (Supplemental Dues).

There are no further increases applicable to this determination.
