Citation 1 Item 1 Type of Violation: Repeat Serious

§3314(c). The Control of Hazardous Energy for the Cleaning, Repairing, Servicing, Setting-Up, and Adjusting Operations of Prime Movers, Machinery and Equipment, Including Lockout/Tag out.

"Cleaning, Servicing and Adjusting Operations. Machinery or equipment capable of movement shall be stopped and the power source de-energized or disengaged, and, if necessary, the moveable parts shall be mechanically blocked or locked out to prevent inadvertent movement, or release of stored energy during cleaning, servicing and adjusting operations. Accident prevention signs or tags or both shall be placed on the controls of the power source of the machinery or equipment."

On January 26, 2012, an employee operated the De Francisci Long Goods Spaghetti Stripper (Costa Macaroni # 01138), located at the Southwest corner of the building, but failed to de-energize the spaghetti stripper while cleaning a pasta jam. "Screw conveyors 7 feet or less above floor or other working level shall be completely covered with substantial lids except that screw conveyors the top of which are 2 feet or less above the floor or other working level, or below the floor level may be guarded by standard railing guards having toeboards of midrail height or shall be guarded by substantial covers or gratings."

On or before April 5, 2012, employees operated the De Francisci Long Goods Spaghetti Stripper (Costa Macaroni # 01138), located at the Southeast corner of the building, and the screw conveyor was not guarded.

§4075(a). Gears and Sprockets.

"All gears, sprockets and sprocket chain drives located 7 feet or less above the floor or working level shall be guarded."

On January 26, 2012, an employee operated the De Francisci Long Goods Spaghetti Stripper (Costa Macaroni # 01138), located at the Southwest corner of the building, and was injured by an unguarded gear and sprocket. Also on or before April 5, 2012, the gears and sprockets were not guarded at the following locations:

1. The gear and sprocket located on the De Francisci Spaghetti Stripper (Costa Macaroni # 01138), located at the Southeast corner of the building on the North side by the emergency stop;
2. The gear and sprocket located below the Flour Feed Platform adjacent to the control panel;
3. The two gears and sprockets located at the pole feed on the North side;
4. The two gears and sprockets located at the pole drop off areas on the East side;
5. The gear and sprocket located at the Line 1 Mixer;
6. The gear and sprocket located on line 2 adjacent to the Line 1 Mixer;
7. The gear and sprocket located on the inside of the conveyor drive for the shaker;
8. The gear and sprocket located on the inside of the De Francisci Spaghetti Stripper (Costa Macaroni # 01138), and
9. The gear and sprocket located inside the cabinet on the North side of the Pavan (Costra Macaroni # 01035).

This is a Repeat Violation of Citation number 4 Item number 1, Inspection number 313508046, Report number 028-10, Region 3 District 3, Issued on August 30, 2010. This citation became a final order of the Board on February 28, 2011.


