**Determination:**

A Request for Independent Bill Review (IBR) was assigned to MAXIMUS Federal Services on 12/20/2013, by the Administrative Director of the California Division of Workers' Compensation pursuant to California Labor Code section 4603.6. MAXIMUS Federal Services has determined that the **Claims Administrator's determination is reversed. The Claims Administrator is required to reimburse you the IBR fee of \$335.00 and the amount found owing of \$2,363.35, for a total of \$2,698.35.**

**Pertinent Records and Other Appropriate Information Relevant to the Determination Reviewed:**

The following evidence was used to support the decision:

- The original billing itemization
- Supporting documents submitted with the original billing
- Explanation of Review in response to the original bill
- Request for Second Bill Review and documentation
- Supporting documents submitted with the request for second review
- The final explanation of the second review
- Official Medical Fee Schedule or negotiated contract: PPO Contract
- Other: Official Medical Fee Schedule guidelines

### Supporting Analysis:

The dispute regards payment amount for functional restoration program services provided during 1/28/2013-2/01/2013. The Provider billed CPT 97799 Modifier 86, was reimbursed \$3,036.65, and is requesting additional reimbursement of \$2,363.35. The Claims Administrator reimbursed the Provider \$3,036.65 indicating "Authorization attached is for Functional Restoration Program not for the above billed amount. Flat \$674.81 is paid for an 8 hour day plus application of the PPO discount rate."

CPT 97799 - Unlisted physical medicine service or procedure.

Modifier 86 - This modifier is to be used when prior authorization was received for services that exceed the OMFS ground rules.

The documentation submitted included an authorization for Functional Restoration Program for 10 days/two weeks (97799). The report submitted by the Provider documented the progress of the injured worker which included: functional observations and measurements; cardiovascular; lifting; range of motion; strength; posture and psychological assessment. The request for treatment authorization from the Provider, documented the CPT code billed (97799) and cost per 5 days of treatment \$6,000.00. The authorization from the Claims Administrator did not indicate a pre-negotiated allowance of \$674.81 per day for 5 days of functional restoration program services.

Based on a review of the PPO contract, the reimbursement rate for services rendered would be the lesser of 90% of billed charges, or usual and customary prevailing rates or the current applicable fee schedule. The Official Medical Fee Schedule does not list a value for CPT 97799. The Provider submitted a copy of an explanation of review for the same worker demonstrating their usual and customary charge of \$6000.00 and reimbursement of \$5,400.00 (90% of billed charges) for 5 days of functional restoration program services. Therefore, the payment made by the Claims Administrator for the services rendered 1/28/2013-2/01/2013 was not paid according to the PPO contract. The reimbursement should have been based on 90% of the billed charges or the Providers usual and customary charge of \$6,000.00.

Additional reimbursement of \$2,363.35 is warranted for the Official Medical Fee Schedule code 97799 Modifier 86.

The chart below provides a comparison of billed charges and reimbursement rates for the codes and date of services at issue.

MAXIMUS Federal Services, as the Independent Bill Review Organization, has determined the Claims Administrator owes the Provider additional reimbursement. The Claims Administrator is required to reimburse the Provider for the IBR application fee (**\$335.00**) and the OMFS amount for CPT code 97799 Modifier 86 (\$2,363.35) for a total of \$2,698.35.
