MAXIMUS Federal Services has completed the Independent Bill Review (“IBR”) of the above workers’ compensation case. This letter provides you with the IBR Final Determination and explains how the determination was made.

Final Determination: OVERTURN. MAXIMUS Federal Services has determined that additional reimbursement is warranted. The Claims Administrator’s determination is reversed and the Claim Administrator owes the Provider additional reimbursement of \$195.00 for the review cost and \$2171.68 in additional reimbursement for a total of \$2366.68. A detailed explanation of the decision is provided later in this letter.

The Claim Administrator is required to reimburse the Provider a total of \$2366.88 within 45 days of the date on this letter per section 4603.2 (2a) of the California Labor Code. The determination of MAXIMUS Federal Services and its expert reviewer is deemed to be the Final Determination of the Administrative Director of the Division of Workers’ Compensation. This determination is binding on all parties. In certain limited circumstances, you can appeal the Final Determination. Appeals must be filed with the Workers’ Compensation Appeals Board within 20 days from the date of this letter. For more information on appealing the final determination, please see California Labor Code Section 4603.6(f).

HOW THE IBR FINAL DETERMINATION WAS MADE

MAXIMUS Federal Services Chief Coding Specialist reviewed the case file and researched pertinent coding and billing standards to reach a determination. In some cases a physician reviewer was employed to review the clinical aspects of the care to help make a determination. He/she has no affiliation with the employer, employee, providers or the claims administrator. The expert reviewer was selected based on his/her clinical experience, education, background, and expertise in the same or similar specialties that evaluate and/or treat the medical condition and disputed items/services.

ANALYSIS AND FINDING

Based on review of the case file the following is noted:

- **ISSUE IN DISPUTE:** Provider is dissatisfied with reimbursement of code 97799-86
- Claims Administrator reimbursed code indicating on the Explanation of Review “The Official Medical Fee Schedule does not list this code. An allowance has been made for a comparable service”
- Due to the complexity factors involved of the Functional Restoration Program, CPT 97750 is not a good comparison for 97799.
- Provider requested 10 days/50 hours of full-time participation in FRP (5 hours per day). Provider documented CPT code to be used as 97799 modifier -86. Charges for 97799 billed at a rate of \$1000.00 per day (\$5000.00 per week) were also documented.
- Utilization Review accepted the RFA in full showing an expiration on 12/12/14.
- Based on information reviewed, additional reimbursement for 97799-86 is warranted.

DETERMINATION OF ISSUE IN DISPUTE: Reimbursement of code 97799-86 is recommended.
