HOW THE IMR FINAL DETERMINATION WAS MADE

MAXIMUS Federal Services sent the complete case file to an expert reviewer. He/she has no affiliation with the employer, employee, providers or the claims administrator. The expert reviewer is Board Certified in Neurological Surgery and is licensed to practice in California. He/she has been in active clinical practice for more than five years and is currently working at least 24 hours a week in active practice. The expert reviewer was selected based on his/her clinical experience, education, background, and expertise in the same or similar specialties that evaluate and/or treat the medical condition and disputed items/services. He/she is familiar with governing laws and regulations, including the strength of evidence hierarchy that applies to Independent Medical Review determinations.

CLINICAL CASE SUMMARY

The expert reviewer developed the following clinical case summary based on a review of the case file, including all medical records:

The records presented for review indicate that this 43 year-old individual was reportedly injured on October 11, 2000. The medical records presented for review was a letter of noncertification of a request for multiple procedures. An August 14, 2014 supplemental report, response to utilization review letter noted a requesting provider took umbrage at the determination. References made to numerous progress notes however none are attached. The impression was degenerative disc disease of the lumbar spine with facet arthropathy, a solid arthrodesis (fusion) with loose hardware. A request is made to remove the fusion hardware. It is noted that a lumbar fusion procedure was completed in December, 2011. A previous progress note indicated some muscle spasm lumbar spine, and altered gait pattern, and pain with extension and rotation. The loose hardware was noted. There continued to be low back complaints. Diagnostic imaging studies noted the fusion graft, the decompressive laminectomy and partial left medial facet ectomy changes. The lumbar fusion and adjacent hardware is noted. Previous treatment includes lumbar fusion surgery, Arthroscopy, injections, pain management interventions. A request had been made for surgical intervention and associated assessments and was not certified in the pre-authorization process on June 10, 2014.

IMR ISSUES, DECISIONS AND RATIONALES

The Final Determination was based on decisions for the disputed items/services set forth below:

Hardware removal L4-5, L5-S1 with possible revision fusion w/laminectomy: Upheld

Claims Administrator guideline: Decision based on MTUS ACOEM Chapter 12 Low Back Complaints.

MAXIMUS guideline: The Expert Reviewer did not base their decision on the MTUS. Decision based on Non-MTUS Citation Official Disability Guidelines (ODG) low back chapter updated July, 2014

Decision rationale: There is no clinical evidence presented to support the underlying surgical request. As noted in the ODG, hardware removal is not recommended except in cases of broken hardware or persistent pain. There is no objectification of the hardware is broken, loose or a pain generator. Therefore, the request is not medically necessary.
