### HOW THE IMR FINAL DETERMINATION WAS MADE

MAXIMUS Federal Services sent the complete case file to an expert reviewer. He/she has no affiliation with the employer, employee, providers or the claims administrator. The expert reviewer is Board Certified in Orthopedic Surgery, and is licensed to practice in California. He/she has been in active clinical practice for more than five years and is currently working at least 24 hours a week in active practice. The expert reviewer was selected based on his/her clinical experience, education, background, and expertise in the same or similar specialties that evaluate and/or treat the medical condition and disputed items/services. He/she is familiar with governing laws and regulations, including the strength of evidence hierarchy that applies to Independent Medical Review determinations.

### CLINICAL CASE SUMMARY

The expert reviewer developed the following clinical case summary based on a review of the case file, including all medical records:

55-year-old male cleaned with reported industrial injury on February 13, 2014. Exam note 10/6/14 demonstrates complaints of bilateral knee pain, worse on the left than the right. Pain is located around the patella and medial and lateral joint line. MRI left knee from 2/25/14 demonstrates tricompartmental degenerative arthritis, partial ACL tear with medial meniscus tear with subluxation and patellar tendonitis. Exam of the knee on the left demonstrates a small effusion, 4/5-quadriceps strength and range of motion of 0-120 degrees. There is patellofemoral tenderness and positive patellar compression test. McMurray's test is negative and the knee is stable to all stress. Radiographs demonstrated bone on bone in the medial compartment on the left with patellofemoral osteophyte formation and degenerative changes.

### IMR ISSUES, DECISIONS AND RATIONALES

The Final Determination was based on decisions for the disputed items/services set forth below:

**Left total knee arthroplasty:** Upheld

**Claims Administrator guideline:** The Claims Administrator did not base their decision on the MTUS. Decision based on Non-MTUS Citation Official Disability Guidelines (ODG)

**MAXIMUS guideline:** The Expert Reviewer did not base their decision on the MTUS. Decision based on Non-MTUS Citation Official Disability Guidelines (ODG) Knee and Leg , Knee Arthroplasty

**Decision rationale:** CA MTUS/ACOEM is silent on the issue of total knee replacement; according to the Official Disability Guidelines regarding knee arthroplasty: Criteria for knee joint replacement which includes conservative care with subjective findings including limited range of motion less than 90 degrees. In addition the patient should have a BMI of less than 35 and be older than 50 years of age. There must also be findings on standing radiographs of significant loss of chondral clear space. The clinical information submitted demonstrates insufficient evidence to support a knee arthroplasty in this patient. There is no documentation from the exam notes from 10/6/14 of increased pain with initiation of activity or weight bearing. There are no records in the chart documenting when physical therapy began or how many visits were attempted. There is no evidence in the cited examination notes of limited range of motion less than 90 degrees. Therefore the guideline criteria have not been met and the request is not medically necessary.

**Associated surgical service: Inpatient hospital stay, 3 days:** Upheld
