HOW THE IMR FINAL DETERMINATION WAS MADE

The expert reviewer was selected based on his/her clinical experience, education, background, and expertise in the same or similar specialties that evaluate and/or treat the medical condition and disputed items/Service. He/she is familiar with governing laws and regulations, including the strength of evidence hierarchy that applies to Independent Medical Review determinations.

CLINICAL CASE SUMMARY

The expert reviewer developed the following clinical case summary based on a review of the case file, including all medical records:

This 32 year old woman sustained an industrial injury on 5/2/2013. The mechanism of injury is not detailed. Diagnoses include re-tear of rotator cuff. Treatment has included oral medications and physical therapy. Physician notes on a PR-2 dated 4/27/2015 show complaints of continued difficulties with the shoulder. MR arthrogram from 3/10/15 demonstrates an intrasubstance abnormality considered to be a partial tear. Recommendations include surgical intervention including pre-operative internal medicine clearance, RN assessment for post-operative wound care and home aid, post-operative home physical therapy, motorized cold therapy unit, deep vein thrombosis unit, continuous passive motion machine, ultra sling with abduction pillow, pain pump, and follow up in five weeks.

IMR ISSUES, DECISIONS AND RATIONALES

The Final Determination was based on decisions for the disputed items/services set forth below:

Right Shoulder Arthroscopy versus Open Rotator Cuff Repair: Upheld

Claims Administrator guideline: The Claims Administrator did not base their decision on the MTUS. Decision based on Non-MTUS Citation Official Disability Guidelines (ODG); Shoulder.

MAXIMUS guideline: Decision based on MTUS ACOEM Chapter 9 Shoulder Complaints Page(s): 209-210. Decision based on Non-MTUS Citation Official Disability Guidelines (ODG) Shoulder, Surgery for rotator cuff repair.

Decision rationale: According to the CA MTUS/ACOEM Shoulder Chapter, page 209-210, surgical considerations for the shoulder include failure of four months of activity modification and existence of a surgical lesion. In addition the guidelines recommend surgery consideration for a clear clinical and imaging evidence of a lesion shown to benefit from surgical repair. The ODG Shoulder section, surgery for rotator cuff repair, recommends 3-6 months of conservative care with a painful arc on exam from 90-130 degrees and night pain. There also must be weak or absent abduction with tenderness and impingement signs on exam. Finally there must be evidence of temporary relief from anesthetic pain injection and imaging evidence of deficit in rotator cuff. In this case the submitted notes from 4/27/15 do not demonstrate 4 months of failure of activity modification. The MR arthrogram from 3/10/15 does not demonstrate a significant high grade or full thickness tear. Therefore the determination is not medically necessary for the requested procedure.

Internal Medicine Preoperative Clearance: Upheld
