HOW THE IMR FINAL DETERMINATION WAS MADE

CLINICAL CASE SUMMARY

The expert reviewer developed the following clinical case summary based on a review of the case file, including all medical records:

The injured worker is a (n) 48 year old female, who sustained an industrial injury on 9-20-08. She reported injury to her lower back after a slip and fall accident. The injured worker was diagnosed as having lumbago. Treatment to date has included physical therapy, chiropractic treatments and a lumbar MRI showing L4-L5 moderate facet degenerative changes. Current medications include Zanaflex, Norco, Naprosyn, Prilosec and Cymbalta. As of the PR2 dated 6-25-15, the injured worker reports back stiffness, numbness in left arm and hip pain. She rates her pain a 7 out of 10 in her lower back. Objective findings include a positive straight leg raise test on the left at 90 degrees, a positive Faber maneuver and tenderness in the paraspinal muscles. She was authorized for an EMG study but the results were not available for review. The treating physician requested a lumbar lateral interbody fusion at L4-L5 posterior with instrumentation, post-op physical therapy 2 x weekly for 6 weeks, a post-op lumbar x-ray, a bone growth stimulator, a post-op lumbar brace, pre-op medical clearance, a pre-op EKG, a pre-op chest x- ray, pre-op labs, a first assistant and an inpatient stay x 2 days.

IMR ISSUES, DECISIONS AND RATIONALES

The Final Determination was based on decisions for the disputed items/services set forth below:

Lumbar lateral interbody fusion with L4-5 posterior with instrumentation at L4-5: Upheld

Claims Administrator guideline: The Claims Administrator did not cite any medical evidence for its decision.

MAXIMUS guideline: Decision based on MTUS ACOEM Chapter 12 Low Back Complaints Page(s): 305-307.

Decision rationale: The California MTUS guidelines do recommend a spinal fusion for traumatic vertebral fracture, dislocation and instability. This patient has not had any of these events. The guidelines note that the efficacy of fusion in the absence of instability has not been proven. The requested treatment: Lumbar lateral interbody fusion with L4-5 posterior with instrumentation at L4-5 is not medically necessary and appropriate

Post-op physical therapy 2 x 6 for the lumbar spine: Upheld
