CLINICAL CASE SUMMARY

The expert reviewer developed the following clinical case summary based on a review of the case file, including all medical records:

The injured worker is a 44 year old, male who sustained a work related injury on 5-29-12. The diagnoses have included lumbar disc herniation L5-S1 with probable conjoint nerve root, chronic S1 radiculopathy based on EMG done on 8-21-12, discopathy L4-5 through S1, facet arthrosis L2 through S1 and status post lumbar spine surgery on 1-16-14. Treatments have included oral medications, physical therapy, pool therapy, a lumbar epidural steroid injection, and TENS unit therapy. In the PR-2 dated 4/10/15, the injured worker reports significant pain in his lower back with radiation down the left buttock and left leg. On physical exam, he has focal tenderness on the L5-S1 level as well as along the left sciatic notch. He has pain in his left buttock with prolonged sitting. Motor strength testing is stable. "Based on the EMG and nerve conduction studies, there is S1 chronic radiculopathy noted." He has no active radiculopathy at present. A "prior MRI of the lumbar spine demonstrates left-sided foraminal disc protrusion and central annular tear at the L4-L5 level. There is also central disc extrusion at the L5-S1 level." He is not working. The treatment plan includes a request to proceed with lumbar spine surgery.

IMR ISSUES, DECISIONS AND RATIONALES

The Final Determination was based on decisions for the disputed items/services set forth below:

Anterior lumbar interbody fusion & posterior spinal fusion at L4-S1 with decompression:
 Upheld

Claims Administrator guideline: Decision based on MTUS ACOEM Chapter 12 Low Back Complaints.

MAXIMUS guideline: Decision based on MTUS ACOEM Chapter 12 Low Back Complaints Page(s): 307. Decision based on Non-MTUS Citation Official Disability Guidelines (ODG) Low back, Fusion.

Decision rationale: The ACOEM Guidelines Chapter 12 Low Back Complaints page 307 state that lumbar fusion, Except for cases of trauma-related spinal fracture or dislocation, fusion of the spine is not usually considered during the first three months of symptoms. Patients with increased spinal instability (not work-related) after surgical decompression at the level of degenerative spondylolisthesis may be candidates for fusion. According to the ODG, Low back, Fusion (spinal) should be considered for 6 months of symptom. Indications for fusion include neural arch defect, segmental instability with movement of more than 4.5 mm, revision surgery where functional gains are anticipated, infection, tumor, deformity and after a third disc herniation. In addition, ODG states, there is a lack of support for fusion for mechanical low back pain for subjects with failure to participate effectively in active rehab pre-op, total disability over 6 months, active psych diagnosis, and narcotic dependence. In this particular patient, there is lack of medical necessity for lumbar fusion as there is no evidence of segmental instability greater than 4.5 mm, severe stenosis or psychiatric clearance from the exam note of 4/10/15 to warrant fusion. Therefore, the request is not medically necessary for lumbar fusion.
