**ORDER DISMISSING  
CONSOLIDATED LIENS**

Notice of the Lien Conference of 11-18-2020 was served on the suspended provider and lien claimants, Lauren Papa DC/Lauren Papa DC, A Chiropractic Corporation by the Department of Industrial Relations Anti-Fraud Unit on 10-27-2020. At the Lien Conference, Lauren Papa DC; Lauren Papa DC, a Chiropractic Corporation and/or their representatives, failed to appear. The matter was continued to another Lien Conference on 1-20-2021. Notice of the Lien Conference of 1-20-2021 was served on the suspended provider and lien claimants, Lauren Papa DC/Lauren Papa DC, A Chiropractic Corporation by the Department of Industrial Relations Anti-Fraud Unit on 11-24-2020 and again by Liaison Counsel on 1-7-2021.

A Notice of Intent to Dismiss pursuant to Title 8 of California Code of Regulations 10832 (D)(1) issued on 1-20-2021 and was served on Lauren Papa DC; Lauren Papa DC, a Chiropractic Corporation by the Department of Industrial Relations Anti-Fraud Unit on 1-28-2021.

To date, no objection to the 1-20-2021 Notice of Intent to Dismiss has been filed with this court, or served on the Department of Industrial Relations Anti-Fraud Unit, Carrier Liaison Counsel Mokri, Vanis & Jones, or any of the other parties to this matter.

As no objection to the 1-20-2021 Notice of Intent to Dismiss has been filed or served by Lauren Papa DC/Lauren Papa DC, a Chiropractic Corporation to date, and the period of such objection has expired,

**IT IS HEREBY ORDERED**, that any and all lien claims and lien balances filed with the Workers' Compensation Appeals Board by Lauren Papa DC, Lauren Papa DC, a Chiropractic Corporation are hereby **DISMISSED WITH PREJUDICE**.
