French that the suspension would start thirty (30) calendar days after the date of mailing of written notice, unless Sarah N. French submitted a written request for a hearing within ten (10) calendar days of the date of mailing of the notice; and

WHEREAS, Sarah N. French did not submit a written request for hearing within ten
(10) calendar days of the date of mailing of the notice; and
