THE DIRECTOR'S GENERAL PREVAILING WAGE DETERMINATIONS**

DETERMINATION(s): NC-31-X-16-2007-1

LOCALITIES: All Localities within Alameda, Alpine, Amador, Butte, Calaveras, Colusa, Contra Costa, Del Norte, El Dorado, Fresno, Glenn, Humboldt, Kings, Lake, Lassen, Madera, Marin, Mariposa, Mendocino, Merced, Modoc, Monterey, Napa, Nevada, Placer, Plumas, Sacramento, San Benito, San Francisco, San Joaquin, San Mateo, Santa Clara, Santa Cruz, Shasta, Sierra, Siskiyou, Solano, Sonoma, Stanislaus, Sutter, Tehama, Trinity, Tulare, Tuolumne, Yolo, and Yuba counties

Footnote "c" under "Area 3 – All remaining counties" is incorrect. The correct footnote should read:

- **Area 3** – El Dorado¹, Placer¹, Sacramento, San Joaquin, and Yolo Counties.

Area 4, which was inadvertently omitted on this determination, covers the remaining counties not covered in Area 3 and should read as follows:

- **Area 4** – Alpine, Amador, Butte, Calaveras, Colusa, Del Norte, El Dorado¹, Fresno, Glenn, Humboldt, Kings, Lake, Lassen, Madera, Mariposa, Mendocino, Merced, Modoc, Nevada, Placer¹, Plumas, Shasta, Sierra, Siskiyou, Stanislaus, Sutter, Tehama, Trinity, Tulare, Tuolumne, and Yuba Counties.

The wage information for Area 4 is the same in Area 3 as listed on NC-31-X-16-2007-1 determination. For predetermined changes, please refer to the scheduled predetermined increase page posted on the internet @ <http://www.dir.ca.gov/dlsr/pwd/Increases/Northern/NC-031-X-16-Pre.pdf>.

Additionally, **footnote "h"** regarding the fifty million (\$50,000,000) threshold has been deleted and is no longer applicable for the above determination.

¹ Area 3 includes the portion of Placer County west of and including Highway 49 and the portion of El Dorado County west of and including Highway 49 and the territory inside the city limits of Placerville. Area 4 includes the portions of Placer and El Dorado Counties not covered in Area 3.
