This predetermined increase for the above named craft applies only to the current determination for work being performed on public works projects with bid advertisement dates on or after **March 4, 2013**, until this determination is superseded by a new determination or a predetermined increase modification notice becomes effective.

When referencing our prevailing wage determinations, please note that if the prevailing wage rate determination which was in effect on the bid advertisement date of a project has a single asterisk (*) after the expiration date, the rate will be good for the life of the project. However, if a prevailing wage rate determination has double asterisks (**) after the expiration date, the rate must be updated on the following date to reflect the predetermined rate change(s).

LANDSCAPE/IRRIGATION LABORER: Engineering and Building Construction

Determinations SD-102-X-14-2013-1 and SD-102-X-14-2013-1A are currently in effect and expire on July 31, 2013**.

Effective August 1, 2013, there will be an increase of \$1.25 allocated as follows: \$0.90 to Basic Hourly Rate and \$0.35 to Vacation and Holiday.

Effective August 1, 2014, there will be an increase of \$1.75 allocated as follows: \$1.25 to the Basic Hourly Rate, \$0.25 to Pension, \$0.22 to Vacation and Holiday, and \$0.03 to Other.

There will be no further increases applicable to this determination.

LANDSCAPE HYDRO SEEDER: Engineering and Building Construction

Determinations SD-102-X-14-2013-1 and SD-102-X-14-2013-1A are currently in effect and expire on July 31, 2013**.

Effective August 1, 2013, there will be an increase of \$1.25 allocated as follows: \$0.90 to Basic Hourly Rate and \$0.35 to Vacation and Holiday.

Effective August 1, 2014, there will be an increase of \$1.75 allocated as follows: \$1.25 to the Basic Hourly Rate, \$0.25 to Pension, \$0.22 to Vacation and Holiday, and \$0.03 to Other.

There will be no further increases applicable to this determination.
