PREDETERMINED INCREASES FOR
ELECTRICAL UTILITY LINEMAN (C-61-X-8-2013-1)
ALL LOCALITES WITHIN
DEL NORTE, MODOC, AND SISKIYOU COUNTIES

This predetermined change for the above named craft applies only to the current determination for work being performed on public works projects with bid advertisement dates on or after **September 1, 2013**, until this determination is superseded by a new determination or a predetermined change modification notice becomes effective.

When referencing our prevailing wage determinations, please note that if the prevailing wage rate determination which was in effect on the bid advertisement date of a project has a single asterisk (*) after the expiration date, the rate will be good for the life of the project. However, if a prevailing wage rate determination has double asterisks (**) after the expiration date, the rate must be updated on the following date to reflect the predetermined rate change(s).

ELECTRICAL UTILITY LINEMAN: ALL CLASSIFICATIONS

Determination C-61-X-8-2013-1 is currently in effect and expires on January 31, 2014**.

LINEMAN, HEAVY LINE EQUIPMENT MAN, CERTIFIED LINEMAN WELDER, POLE SPRAYER

Effective February 1, 2014, there will be an increase of \$1.76. \$1.25 to be allocated to Basic Hourly Rate, \$0.04 to NEBF, \$0.45 to Pension, \$0.01 to Training, and \$0.01 to Other.

CABLE SPLICER

Effective February 1, 2014, there will be an increase of \$1.90. \$1.40 to be allocated to Basic Hourly Rate, \$0.04 to NEBF, \$0.45 to Pension, and \$0.01 to Training.

LINE EQUIPMENT MAN

Effective February 1, 2014, there will be an increase of \$1.42. \$1.08 to be allocated to Basic Hourly Rate, \$0.03 to NEBF, \$0.30 to Pension, and \$0.01 to Training.

POWDERMAN

Effective February 1, 2014, there will be an increase of \$1.17. \$0.93 to be allocated to Basic Hourly Rate, \$0.03 to NEBF, \$0.20 to Pension, and \$0.01 to Training.

GROUNDMAN

Effective February 1, 2014, there will be an increase of \$0.20. \$0.20 to be allocated to Pension.

POLE SPRAYER TRAINEE:

First six months

Effective February 1, 2014, there will be an increase of \$1.31. \$1.07 to be allocated to Basic Hourly Rate, \$0.03 to NEBF, \$0.20 to Pension, and \$0.01 to Training.

Second six months

Effective February 1, 2014, there will be an increase of \$1.36. \$1.12 to be allocated to Basic Hourly Rate, \$0.03 to NEBF, \$0.20 to Pension, and \$0.01 to Training.

Third six months

Effective February 1, 2014, there will be an increase of \$1.40. \$1.16 to be allocated to Basic Hourly Rate, \$0.03 to NEBF, \$0.20 to Pension, and \$0.01 to Training.
