

PREDETERMINED INCREASE

CRAFT:

Traffic Control/Lane Closure (Laborer) and Parking and Highway Improvement Painter (Laborer)

DETERMINATIONS:

NC-23-102-13-2015-2 and NC-23-102-13-2016-1A

LOCALITIES:

All localities within Alameda, Alpine, Amador, Butte, Calaveras, Colusa, Contra Costa, Del Norte, El Dorado, Fresno, Glenn, Humboldt, Kings, Lake, Lassen, Madera, Mariposa, Marin, Mendocino, Merced, Modoc, Monterey, Napa, Nevada, Placer, Plumas, Sacramento, San Benito, San Francisco, San Joaquin^a, San Mateo, Santa Clara, Santa Cruz, Shasta, Sierra, Siskiyou, Solano, Sonoma, Stanislaus, Sutter, Tehama, Trinity, Tulare, Tuolumne^a, Yolo^a, and Yuba Counties.

The predetermined increases for the above named crafts apply only to the current determinations for work being performed on public works projects with bid advertisement dates on or after September 1, 2015 for determination NC-23-102-13-2015-2 and on or after March 3, 2016 for determination NC-23-102-13-2016- 1A, until these determinations are superseded by a new determination or a predetermined increase modification notice becomes effective.

When referencing our prevailing wage determinations, please note that if the prevailing wage rate determination which was in effect on the bid advertisement date of a project, has a single asterisk (*) after the expiration date, the rate will be good for the life of the project. However, if a prevailing wage rate determination has double asterisks (**) after the expiration date, the rate must be updated on the following date to reflect the predetermined rate change(s).

TRAFFIC CONTROL/LANE CLOSURE (LABORER)

Determination NC-23-102-13-2015-2 is currently in effect and expires on June 26, 2016**.

Effective June 27, 2016, there will be an increase of \$1.50 to be allocated as follows: \$0.50 to the Basic Hourly Rate, \$0.30 to Health and Welfare, \$0.68 to Pension and \$0.02 to Training.

Effective June 26, 2017, there will be an increase of \$1.60 allocated as follows: \$0.50 to Basic Hourly Rate, \$0.16 to Health & Welfare, and \$0.94 to Pension.

Effective June 25, 2018, there will be an increase of \$1.65 allocated as follows: \$1.00 to the Basic Hourly Rate, \$0.25 to Health & Welfare, \$0.20 to Pension, \$0.12 to Vacation & Holiday, and \$0.08 to Other.

There will be no further increases applicable to these determinations.

PARKING AND HIGHWAY IMPROVEMENT PAINTER (LABORER)

Determination NC-23-102-13-2016-1A is currently in effect and expires on June 26, 2016**.

Effective June 27, 2016, there will be an increase of \$1.50 to be allocated as follows: \$0.33 to the Basic Hourly Rate, \$0.30 to Health and Welfare, \$0.83 to Pension and \$0.04 to Training.

Effective June 26, 2017, there will be an increase of \$1.60 allocated as follows: \$0.50 to Basic Hourly Rate, \$0.16 to Health & Welfare, and \$0.94 to Pension.

Effective June 25, 2018, there will be an increase of \$1.65 allocated as follows: \$0.65 to the Basic Hourly Rate, \$0.25 to Health & Welfare, \$0.40 to Pension, \$0.27 to Vacation & Holiday, and \$0.08 to Other.

There will be no further increases applicable to this determination.
