## **NOTICE OF STANDARDS APPROVED**

After proceedings held in accordance with and pursuant to authority vested in Sections 142, 142.3 and 142.4 of the Labor Code to implement interpret, or make specific, the Occupational Safety and Health Standards Board, by a majority vote, adopted additions, revisions or deletions to the California Code of Regulations as follows:

1. Title 8, Division 1, Chapter 4, Subchapter 4, Construction Safety Orders, Article 29, Section 1709(a), **Maximum Allowable Load**.

Heard at the August 19, 2010, Public Hearing; adopted on November 18, 2010; filed with the Secretary of State on December 29, 2010; and became effective on January 28, 2011.

2. Title 8, Division 1, Chapter 4, Subchapter 7, General Industry Safety Orders, Article 116, Section 5291(b), **Firing of Explosive Materials (Blasting Operations)**.

Heard at the October 21, 2010, Public Hearing; adopted on December 16, 2010; filed with the Secretary of State on February 1, 2011; and will become effective on March 3, 2011.
